### Reflecting on 2023:

## **Philanthropic Milestones and Community Impact**

In 2023, the Springfield Foundation achieved significant milestones, opening 23 new funds and receiving \$12.6 million in charitable gifts. We distributed over \$686,000 through 400 scholarship awards, and approved funding for 100 projects through our discretionary grant program. Additionally, we celebrated our 75th Anniversary, initiated a multi-year grant to address youth mental health, and supported various community projects, showcasing our commitment to philanthropy and community betterment.

- Launched a new software platform which included the GoFund Online Donor Portal.
- Celebrated our 75th Anniversary culminating with a Gala at the Hollenbeck Bayley Center with over 250 guests in attendance.
- Co-Created a collaborative comprised of community leaders dedicated to lowering youth violence in our community. This group successfully obtained a \$1.6 million technical assistance grant to investigate the gun violence problems in our community and identify effective strategies to reduce youth violence.
- Selected a new initiative supporting a joint mental and behavioral health initiative in collaboration with Rocking Horse Community Health Center, focused on the school-based health clinic at Springfield High School. The Foundation is dedicating \$375,000 toward this initiative.
- Provided financing support for the new Global Impact Stem Academy "Upper Academy" located on the campus of Clark State.

- Provided over 200 local students with coats, hats, and gloves through a Winter Coat Drive supported by our donors, board, and staff, and repurposed the allocated holiday card budget to purchase additional coats.
- Board and staff participated in fitting students at a local elementary school with new gym shoes through Shoes for The Shoeless.
- Staff provided volunteer service throughout the year to the Summer Arts Festival, Springfield Cancer Center, Dayton Children's Hospital, the Pink Honor Walk, Kenwood Elementary School, the Children's Garden at Snyder Park, and the Jazz and Blues Festival.
- Attended the Mental Health and Wellness Fair held at Clark State College and spoke with students about the scholarship process and FAFSA.
- Participated at Clark County College Night hosted by the Clark County School Counselors and OACAC.
- Said goodbye to two departing Trustees, Victoria Dawson-Scruse and Jeanne Lampe, who have made invaluable contributions to the organization.

## 2024 Grants

Each year, the Springfield Foundation accepts applications for a highly competitive discretionary grant cycle. Funding is provided to initiatives and projects in arts and culture, civic affairs, education, environment and conservation, animals, health, and human services.

Applications that are in line with the Foundation's grantmaking objectives, derived from a community needs assessment undertaken by the Foundation, are prioritized for consideration. Through this process, the Foundation ensures that only projects with the potential to make a significant impact in Clark County receive funding.

To ensure a fair and impartial evaluation process, a distribution committee performs a rigorous evaluation of applications. Each application is evaluated based on its quality, feasibility, impact, qualifications, and budget before being selected to receive funding. Through this process, the Foundation maintains its commitment to supporting initiatives that have the potential to create positive change in the community.

For the 2024 grant cycle, 100 proposals were funded either fully or partially for a total of \$833,520. These grants are made possible through the generous support of our donors.

This year, anticipate minor revisions to the grant application, so remain alert for further information. To apply, look for more information on our grant information session conducted in either May or June of this year.
