## Philanthropy made easy, flexible and effective

### Step 1: Decide When to Give.

Endowment funds can be created while a donor is alive, or through a will or trust agreement.

### Step 2: Decide What to Give.

Almost any kind of asset can be used to create your fund, such as cash, stock, real estate and life insurance.

### Step 3: Choose the Type of Fund.

A wide variety of funds are available. The staff will help you select the fund type that best fits your needs and priorities.

### Step 4: Choose a Name.

Most of our funds are named for the donor, the donor's family or a loved one. The fund may also remain anonymous.
